## COLOR CODED INSTRUCTIONS FOR COMPLETING TAX LISTING FORM

- A.** The Property key is your new account number
- B.** Review your name and mailing address for accuracy. Make corrections if the information is incorrect or has changed.
- C.** Motor Vehicles: You must list all unlicensed, IRP, apportioned, permanent, or 3-month farm tagged vehicles. Types of vehicles includes cars, trucks, motorcycles, camping trailers, utility trailers, boat trailers, etc. Please provide the name shown on the title, and the year, make, model, VIN number & the purchase cost and year. Do not list registered vehicles with a current annual license tag.
- D.** Boats/Motor: Includes but not limited to all boats, boat motors, jet skis, and all other motorize watercrafts. Please include the year, make, model, length, Hull ID number, and the horsepower.
- E.** Aircrafts: Please include the year, make, model, serial number and registration number and physical location.
- F.** Mobile Homes: All singlewide mobile homes must be listed on this form. Please provide the year, make/model, VIN/Serial number, length and width, purchase cost & year and physical address of the mobile home. For all doublewide and triplewide mobile homes that have one or more of the following conditions, must be listed as well:
- Non-permanent foundation
  - Hitch, wheels & axels still attached
  - Non-Residential structure
- G.** Affirmation of Property Owner: This form must be signed and dated by the owner of the property listed on this form. All forms not signed will be rejected and returned to the owner.

### IMPORTANT NOTICE:

**The listing period begins on January 1st and ends on February 2nd. You must sign and date Section G and mail this entire form back to our office during the listing period. Failure to list during this period will result in a 10% penalty at the time of billing.**

**If additional time is needed to complete this form, please submit a written extension request to the Tax Office by February 2nd.**

Listings submitted by mail shall be deemed to be filed as of the date shown on the postmark affixed by the U.S Postal Service. If no date is shown on the postmark or if a postmarks not affixed by the U.S Postal Service, the listing shall be deemed to be filed when received in the office of the Tax Department.
